1 **WHEREAS, by Resolution No. 06-212, the Tohono O'odham Legislative Council approved the FY**  
2 **2007 Bureau of Indian Affairs (BIA) budgets and Annual Funding Agreement under a**  
3 **P.L. 93-638 Master Contract; and**

4 **WHEREAS, the amount approved in the Master Contract for Social Service/Family Assistance, as**

17 **2008 BIA Social Services Budget, including Indirect cost; and**

18 **WHEREAS, the Executive Branch developed and obtained committee approval of the FY 2008 BIA**  
19 **Social Service/Family Assistance use of carry forward savings in the amount of**  
20 **\$134,482.06.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 22 **1. It hereby approves and authorizes the FY 2008 BIA Social Services/Family**  
23 **Assistance, carry forward savings in the amount of \$134,482.06 and authorizes**  
24 **expenditures in accordance with the attached budget.**
- 25 **2. That the Tohono O'odham Nation's official to wit: the Chairman and Vice-**  
26 **Chairman and any designated official are hereby authorized to negotiate and**  
27 **execute the grant provided however that any amendments affecting the funding**  
28 **levels of this contract shall be submitted for further prior approval by the Tohono**  
29 **O'odham Legislative Council.**
