1 **WHEREAS, during the September 21, 2007 Special Session set by the Legislative Council to**
2 **address FY 2008 budgets, Council did approve Resolution No. 07-615, "Approving FY**
3 **2008 Department of Health and Human Services Head Start Budgets"; and**


4 **WHEREAS, due to incorrect amounts contained in Resolution No. 07-615, it is necessary to**
5 **rescind the resolution and a new resolution with correct amounts be presented to**
6 **Council for approval.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby rescinds**
8 **Resolution No. 07-615, "Approving FY 2008 Department of Health and Human Services**
9 **Head Start Budgets."**

10 **BE IT FURTHER RESOLVED that Council will entertain the resolution approving the FY 2008**
11 **Department of Health and Human Services Head Start Budgets when it is presented**
12 **with the corrected version.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST. Day**
14 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1(d)(2) and (l) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
17 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**


