

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2008 Department of Health and Human Services Child Care and  
Development Fund Budgets)**

**RESOLUTION NO. 07-617**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child**  
4 **Care Services to provide child care services to its young tribal members; and**

5 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
6 **Budgets as attached and incorporated by this reference, to be effective October 1,**  
7 **2007 through September 30, 2008 and requests authorization to expend funds for the**  
8 **FY 2008 Child Care and Development Fund (CCDF) in the amount of \$987,079.00 in the**  
9 **following budgets:**

- 10 **1. FY 2008 CCDF Mandatory Administration - \$158,047.54 + \$30,582.20 (IDC) =**  
11 **\$188,629.74.**
- 12 **2. FY 2008 CCDF Mandatory Program - \$383,221.18 + \$37,958.07 (IDC) = \$421,179.25.**
- 13 **3. FY 2008 CCDF Discretionary Administration - \$88,759.68 + \$17,175.00 (IDC) =**  
14 **\$105,934.68.**
- 15 **4. FY 2008 CCDF Discretionary Program - \$275,105.44 (No IDC).**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
17 **the above listed CCDF Mandatory Administration CCDF Mandatory Program, CCDF**  
18 **Discretionary Administration, and Discretionary Program Budgets for period**  
19 **October 1, 2007 through September 30, 2008.**

20 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend funds for the**  
21 **program listed herein above and as attached in the amounts indicated, effective**  
22 **October 1, 2007 through September 30, 2008 for the FY 2008 Child Care and**  
23 **Development Fund Budgets:**

- 24 **1. FY 2008 CCDF Mandatory Administration - \$158,047.54 + \$30,582.20 (IDC) =**  
25 **\$188,629.74.**
- 26 **2. FY 2008 CCDF Mandatory Program - \$383,221.18 + \$37,958.07 (IDC) = \$421,179.25.**
- 27 **3. FY 2008 CCDF Discretionary Administration - \$88,759.68 + \$17,175.00 (IDC) =**  
28 **\$105,934.68.**
- 29 **4. FY 2008 CCDF Discretionary Program - \$275,105.44 (No IDC).**

5 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>. Day  
6 of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-  
7 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
8 Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,  
9 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
10 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
11 of June 18, 1934 (48 Stat. 984).
