

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2008 Department of Health and Human Services Head Start Budgets)**

**RESOLUTION NO. 07-618**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Head**  
4 **Start Program to provide educational, health, mental health and parent involvement**  
5 **services to children, three to five years of age; and**

6 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
7 **budget as attached and incorporated by this reference, to be effective November 1,**  
8 **2007 through October 31, 2008 and request authorization to expend funds:**

- 9 1. **Head Start Administration Budget- \$201,097.91 + \$38,912.44 (IDC) = \$240,010.35**
- 10 2. **Head Start Program Budget - \$1,139,554.76 + \$220,503.85 (IDC)= \$1,360,058.60**
- 11 3. **Head Start T & TA Budget- \$18,330.00 (IDC not in Budget).**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **the above listed HeadStart Administration Budget, HeadStart Program Budget and**  
14 **the Head Start T & TA Budget for the Period November 1, 2007 through October 31,**  
15 **2008.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Executive Branch to expend funds for the program listed above and as attached in the**  
18 **amount indicated, effective November 1, 2007 through October 31, 2008.**

- 19 1. **Head Start Administration Budget- \$201,097.91 + \$38,912.44 (IDC) = \$240,010.35**
- 20 2. **Head Start Program Budget - \$1,139,554.76 + \$220,503.85 (IDC)= \$1,360,058.60**
- 21 3. **Head Start T & TA Budget- \$18,330.00 (IDC not in Budget).**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Nation's Official, to wit, the Chairman, Vice-Chairman and any designated official are**  
24 **authorized to negotiate and execute the grant, provided however, that any**  
25 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
26 **further prior approval.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st. Day**  
28 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**
