

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2008 Arizona Reimbursable Budget: Child and Adult Care Food Program)**

**RESOLUTION NO. 07-619**

1 **WHEREAS, the Tohono O'odham Nation had historically contracted certain functions from the**  
2 **State of Arizona; and**

3 **WHEREAS, the Arizona Department of Education through the Child and Adult Care Food**  
4 **Program Service Agreement provided reimbursement of funds for food costs**  
5 **incurred based on the guidelines identified in the agreements; and**

6 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
7 **budgets as attached and incorporated by this reference, to be effective October 1,**  
8 **2007 through September 30, 2008 and request authorization to expend the funds:**

9 **1. Child and Adult Care Food Program - \$40,000.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
11 **the Child and Adult Care Food Program FY 2008 Budget and authorizes to expend**  
12 **funds for the program listed herein and as attached in the amounts indicated,**  
13 **effective October 1, 2007 through September 30, 2008:**

14 **1. Child and Adult Care Food Program - \$40,000.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
16 **Nation's Official, to wit: the Chairman, Vice-Chairman and any designated official are**  
17 **authorized to negotiate and execute the grant, provided however, that any**  
18 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
19 **further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
21 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
24 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
25 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
26 **of June 18, 1934 (48 Stat. 984).**
