

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2008 Budget for the Tohono O'odham Nation Vocational Rehabilitation Program, Grant Award #H250D030012)

RESOLUTION NO. 07-620

1 **WHEREAS, the Tohono O'odham Nation, upon enactment of Resolution No. 03-512, accepted a**
2 **5-year grant, beginning October 1, 2003 to September 30, 2008, from the U.S.**
3 **Department of Education, Rehabilitation Services Administration's Section 121**
4 **(Vocational Rehabilitation Service Projects for American Indians with Disabilities)**
5 **under P.L., 102-569 Rehabilitation Act of 1973 as amended; and**

6 **WHEREAS, services under the Tohono O'odham Nation Vocational Rehabilitation Program will**
7 **be provided to eligible enrolled members of the Tohono O'odham Nation living on or**
8 **near the Nation and other federally recognized Native Americans living on the Nation**
9 **with disabilities; and**

10 **WHEREAS, the Tohono O'odham Nation will contribute the required 10% match from the**
11 **Department of Education budget and the General Cost Pool; and**

12 **WHEREAS, the Vocational Rehabilitation Program has developed the FY 2008 budget in amount**
13 **of \$400,000.00 beginning October 1, 2007 through September 30, 2008 and is seeking**
14 **approval of the attached budget.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
16 **approves the Vocational Rehabilitation Program's FY 2008 budget in the amount of**
17 **\$400,000.00 and hereby authorizes expenditure of the funds for the period of October**
18 **1, 2007 through September 30, 2008.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairman and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level shall**
22 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
25 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
28 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
30 **of June 18, 1934 (48 Stat. 984).**
