

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Bureau of Indian Affairs One Stop Division -477 Three Year Budget)**

RESOLUTION NO. 07-621

1 **WHEREAS, the Master 477 budget provides funding for all combined federal programs under the**
2 **Education Department One Stop Division from October 1, 2007 to September 30, 2008**
3 **in the amount of \$1,048,169.17 with projected allocations; and**

4 **WHEREAS, the Master 477 budget has been developed and cost shared with the Arizona**
5 **Department of Economic Security funding to promote smooth transitional services**
6 **for clients with an effective staff cost share to promote de-centralized services; and**


7 **WHEREAS, the Master 477 budget will be modified when federal allocations have been received**
8 **to reflect the actual allocations and the 477 budget is approved on a 3 year basis.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
10 **approve the three year Master 477 Budget for the Education Department - One Stop**
11 **Division effective October 1, 2007 to September 30, 2008 in the projected amount of**
12 **\$1,048,169.17, for FY-08 and authorizes the program to expend the funds.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
14 **Nation's Officials, to wit; the Chairman and any officially appointed designee is**
15 **hereby authorized to execute the contracts and plans, provided however, that any**
16 **amendment affecting the funding or funding levels of this contract shall be**
17 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
19 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
22 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
23 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
24 **of June 18, 1934 (48 Stat. 984).**
