

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Expend FY2008 Revenue in the Amount of \$456,578.40 for the Solid Waste Management Program FY2008 Budget 83-0003 and Approve the Deposit of the FY2008 Revenue Funding to the Bank of America Solid Waste Revenue Account)

RESOLUTION NO. 07-622

1 **WHEREAS, the Tohono O'odham Legislative Council approved a dedicated account for the Solid**
2 **Waste Management Program budget 83-0003 through Resolution No. 98-236; and**

3 **WHEREAS, the Solid Waste Management Program deposits any revenue into the Bank of America**
4 **Solid Waste Revenue Account; and**

5 **WHEREAS, the Solid Waste Management Program has generated \$456,578.40 revenue from**
6 **residential and commercial trash collection fees; and**

7 **WHEREAS, the Solid Waste Management Program will submit a budget amount of \$456,578.40**
8 **for FY2008; and**

9 **WHEREAS, the Solid Waste Management Program FY2008 budget 83-0003 has been reviewed by**
10 **the Legislative Natural Resources Committee and the Budget and Finance**
11 **Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

13 **1) authorizes the expenditure of FY2008 revenue in the amount of \$456,578.40 for**
14 **the Solid Waste Management Program FY2008 budget 83-0003, from October 1,**
15 **2007, in accordance with the budget attached hereto; and**

16 **2) approves the deposit of the FY2008 revenue funding to the Bank of America Solid**
17 **Waste Revenue Account.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairman and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funds or funding level shall**
21 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
23 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by Section**
25 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
