

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Accept and Expend \$401,959.57 from the Indian Health Service
Memorandum of Agreement for the Solid Waste Management Program FY2008
Budget 10-1097)**

RESOLUTION NO. 07-623

1 **WHEREAS, the Tohono O'odham Legislative Council approved a Memorandum of Agreement**
2 **between the Solid Waste Management Program and the Indian Health Service and**
3 **budget 10-1097 through Resolution 97-041 for dump closures; and**

4 **WHEREAS, the Solid Waste Management Program will submit a FY2008 budget for dump**
5 **closures, in the amount of \$401,959.57; and**

6 **WHEREAS, the Solid Waste Management Program budget 10-1097 has been reviewed by the**
7 **Legislative Natural Resources Committee and the Legislative Budget and Finance**
8 **Committee.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
10 **authorizes the acceptance and expenditure of \$401,959.57 from the Indian Health**
11 **Service Memorandum of Agreement, for the Solid Waste Management Program**
12 **FY2008 budget 10-1097, in accordance with the budget attached hereto.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
14 **Chairman and any designated official to expend and administer the budget as**
15 **attached, provided that any amendments affecting the funds or funding level shall be**
16 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st Day**
18 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (d)(2), (d)(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
21 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
22 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
23 **of June 18, 1934 (48 Stat. 984).**
