

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to Accept and Expend the Environmental Protection Agency's Source Water
Assessment Program Grant for the Water Resources Study Program FY2008 Budget 11-5020)**

RESOLUTION NO. 07-626

1 **WHEREAS, the Water Resources Study Program was awarded a Environmental Protection**
2 **Agency's Source Water Assessment Program (SWAP) grant for the protection of the**
3 **Nation's Tohono O'odham Utility Authority public drinking water system, from**
4 **natural and man-made contamination, in the amount of \$40,000.00; and**

5 **WHEREAS, the Water Resources Study Program SWAP budget has been reviewed by the**
6 **Legislative Water Resources Committee and the Budget and Finance Committee.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
8 **authorizes the acceptance and expenditure of the Environmental Protection Agency**
9 **SWAP grant, in the amount of \$40,000.00 for the Water Resources Study Program**
10 **FY2008 budget 11-5020, in accordance with the budget attached hereto.**

11 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
12 **Chairperson and any designated official to expend and administer the budget as**
13 **attached, provided that any amendments affecting the funds or funding level shall**
14 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST. Day**
16 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.4 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1(d)(2) & (3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
19 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
