

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY-08 Budget for Youth Transportation Art Grant)

RESOLUTION NO. 07-629

1 WHEREAS, the Planning Department's Transportation Program applied for and received grant
2 funding in the original amount of \$50,000.00; and

3 WHEREAS, this project is funded by a Pima Association of Governments grant to enhance
4 community pride by involving District youth in designing public transportation art;
5 and

6 WHEREAS, the Planning Department is requesting approval of the FY-08 Budget of remaining
7 funds in the amount of \$180,332.96; and

8 WHEREAS, the grant will be administered by the Planning Department's Planner.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
10 and authorizes expenditures of the attached budget in the amount of \$180,332.96
11 beginning October 1, 2007.

12 BE IT FINALLY RESOLVED, that the Tohono O'odham Legislative Council hereby authorizes the
13 Chairman and any designated official to expend and administer the budget as
14 attached, provided that any amendments affecting the funds or funding level shall
15 be submitted for further prior approval by the Tohono O'odham Legislative Council.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST. Day
17 of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
18 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
19 Section 1(d)(2) & (3)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
20 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
21 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
22 18, 1934 (48 Stat. 984).
