

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Planning Department, Housing Rehabilitation Project
Administration Budget for Fiscal Year 2008)

RESOLUTION NO. 07-631

1 **WHEREAS, the Tohono O'odham Legislative Council approved the three year funding request of**
2 **\$9,405,649.93 by Resolution #01-661; and**

3 **WHEREAS, the Planning Department's Housing Rehabilitation Project has completed the**
4 **rehabilitation project; and**

5 **WHEREAS, the Housing Rehabilitation Project will need to continue in order to follow-up on**
6 **warranty issues with the homes completed, this will be with identified staff; and**

7 **WHEREAS, the Planning Department has presented a budget for FY-2008 in the amount of**
8 **\$439,040.62 as attached and was presented and approved by the Housing Committee,**
9 **Commerce Committee and Budget & Finance Committee of the Tohono O'odham**
10 **Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
12 **the proposed attached budget and attachments for FY-2008 in the amount of**
13 **\$439,040.62; provided that such funds shall be expended exclusively for the purposes**
14 **identified in Resolution No. 01-661, as amended by Resolution No. 02-070, and**
15 **pursuant to Resolution No. 02-313.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairman and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level shall be**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
21 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(2) & (3)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
24 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
