1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has been awarded the DUI**
2 **Abatement Oversight Council on Driving or Operating Under the Influence**
3 **Abatement grant in the amount of \$14,192.00 with no indirect cost or match required;**
4 **and**

5 **WHEREAS, the TONPD has attached a budget in the amount of \$14,192.00 with line items 660 –**
6 **Travel Expense \$2,000.00, 650 – Tuition & Registration \$4,192.00, 721 – Supplies others**
7 **\$1,000.00, 750– Major Capital \$7,000.00; and**

8 **WHEREAS, the DUI Abatement Oversight Council on Driving or Operating Under the Influence**
9 **Abatement requires an agreement between the TOPD and the Oversight Council on**
10 **Driving or Operating Under the Influence Abatement effective July 1, 2007 thru**
11 **December 31, 2007.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
13 **accepts, approves, and authorizes the DUI Abatement Oversight Council on Driving**
14 **or Operating Under the Influence Abatement grant no. DUI-0A-258 as follows:**

- 15 **1) Accepts the DUI abatement Oversight Council on Driving or Operating Under**
16 **the Influence Abatement grant no DUI-08A-258 in the amount of \$14,192.00**
17 **with no Indirect Cost or match required.**
- 18 **2) Approves the budget under this DUI abatement grant no DUI-08A-258 with line**
19 **item 650 Tuition and Registration, 660 Travel Expenses and 721 Supplies other**
20 **and 750 Major Capital.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
22 **Chairman, Vice Chairman and any designated official to enter into an agreement with**
23 **the Oversight Council on Driving & Operating Under the Influence Abatement to**
24 **expend and administer the budget as attached, provided that any amendments**
25 **affecting the funds or funding level shall be submitted for further prior approval by**
26 **the Tohono O'odham Legislative Council .**
