5		fund the Youth Council; and
6	WHEREAS,	the budget has been presented to the respective Legislative Council oversight
7		committee and Legislative Budget and Finance Committee for review.
8	NOW, THERI	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves
9		the FY 2008 Youth Council budget in the amount of \$235,444.01, which shall be
10		funded with FY 2008 general fund revenues.
11	BE IT FURTI	IER RESOLVED by the Tohono O'odham Legislative Council that the Youth Council
12		recurring base is identified as \$204,444.01 subject to Legislative Council
13		appropriations in subsequent fiscal years beyond FY 2008.
14	BE IT FURTH	ER RESOLVED by the Tohono O'odham Legislative Council that the Youth Council is
15		hereby authorized to carry over unexpended funds from its FY 2008 budget line item
16		750 to the Youth Council FY 2009 budget line item 750; provided that the FY 2009
17		budget is approved by the Legislative Council.
18	BE IT FINALI	Y RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
19		Chairman, Vice-Chairman and any designated official are authorized to administer
20		the FY 2008 Youth Council Budget, provided however, that any amendments
21		affecting the funds or funding levels of the budget shall be submitted for further
22		prior approval by the Tohono O'odham Legislative Council.
