

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Authorizing the Fiscal Year 2008 Office of Emergency Management Budget)**

RESOLUTION NO. 07-639

1 **WHEREAS, the Executive Branch has prepared and presented its fiscal year 2008 budget for the**  
2 **Tohono O'odham Nation for the Office of Emergency Management; and**

3 **WHEREAS, the total fiscal year 2008 budget for the Office of Emergency Management is**  
4 **\$1,649,144.51; and**

5 **WHEREAS, the Nation's FY2008 projected general fund revenues of \$1,649,144.51 is proposed to**  
6 **fund the Office of Emergency Management; and**

7 **WHEREAS, the budget has been presented to the respective Legislative Council oversight**  
8 **committee and Legislative Budget and Finance Committee for review.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**  
10 **the FY 2008 Office of Emergency Management budget in the amount of \$1,649,144.51,**  
11 **which shall be funded with FY 2008 general fund revenues.**

12 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Office of**  
13 **Emergency Management recurring base is identified as \$1,195,144.51, subject to**  
14 **Legislative Council appropriations in subsequent fiscal years beyond FY 2008.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Office of**  
16 **Emergency Management is hereby authorized to carry over unexpended funds from**  
17 **its FY 2008 budget line item 750 to the Office of Emergency Management FY 2009**  
18 **Budget line item 750; provided that the FY 2009 Budget is approved by the Legislative**  
19 **Council.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
21 **Nation's Chairman, Vice-Chairman and any designated official are authorized to**  
22 **administer the FY 2008 Office of Emergency Management Budget, provided however,**  
23 **that any amendments affecting the funds or funding levels of the budget shall be**  
24 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
27 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and 199.2 [07] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**
