

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing the Fiscal Year 2008 Cultural Museum Budget)**

RESOLUTION NO. 07-640

1 **WHEREAS, the Executive Branch has prepared and presented its fiscal year 2008 budget to the**
2 **Tohono O'odham Nation for the Cultural Museum; and**

3 **WHEREAS, the total fiscal year 2008 budget for the Cultural Museum is \$1,300,718.61; and**

4 **WHEREAS, the Nation's FY2008 projected general fund revenues of \$1,169,742.76 is proposed to**
5 **fund the Cultural Museum; and**

6 **WHEREAS, an additional amount \$130,975.85 will need to be appropriated from the Nation's**
7 **Cultural Museum Account for the Cultural Museum to fund the proposed budget; and**

8 **WHEREAS, the budget has been presented to the respective Legislative Oversight Committee and**
9 **Legislative Budget and Finance Committee for review.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**
11 **the FY 2008 Cultural Museum budget in the amount of \$1,300,718.61 in the following**
12 **amounts:**

- 13 **1. Fiscal year 2008 general fund revenue of \$1,169,742.76.**
- 14 **2. A projected additional amount of \$130,975.85 is hereby appropriated from the**
15 **Nation's Cultural Museum Account to fund the Cultural Museum at which time**
16 **the account will be depleted and closed.**

17 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Cultural Museum**
18 **recurring base is identified as \$1,285,718.61, subject to Legislative Council**
19 **appropriations in subsequent fiscal years beyond FY 2008.**

20 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Cultural Museum**
21 **is hereby authorized to carry over unexpected funds from its FY 2008 budget line item**
22 **750 to the Cultural Museum FY 2009 budget line item 750; provided that the FY 2009**
23 **budget is approved by the Legislative Council.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**
26 **authorized to administer the FY 2008 Cultural Museum Budget, provided however,**
27 **that any amendments affecting the funds or funding levels of the budget shall be**
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
