

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Gu-Vo District FY 2008 Budget in the amount of \$1,192,981.78)**

RESOLUTION NO. 07-641

1 WHEREAS, the Gu-Vo District Governing Council did receive the allocated amount of
2 \$1,192,981.78 from the Tohono O'odham Nation Gaming Revenue Distributions given
3 out to all the 11 Districts in equal amount; and

4 WHEREAS, the total amount that the Gu-Vo District was allocated is \$1,192,981.78 for FY 2008;
5 and

6 WHEREAS, the Gu-Vo District did present to its membership the budgets of the Administration,
7 Communities, and also to the Governing Council for review and approval; and

8 WHEREAS, the Gu-Vo District Governing Council has approved the budget for each Community
9 and Administration, and they are as follows:

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
17 approve the Gu-Vo District FY 2008 Budgets in the amount of \$1,192,981.78.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day
19 of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-
20 AGAINST; -0- NOT VOTING; and 199.2 [07] ABSENT, pursuant to the powers vested in the Council by
21 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
22 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24 18, 1934 (48 Stat. 984).
