

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2007 Continuing Resolution for Pisinemo District)**

**RESOLUTION NO. 07-643**

1 **WHEREAS, the current fiscal year expires on September 30, 2007 upon which the authority of the**  
2 **Pisinemo District to expend appropriated funds shall also cease; and**

3 **WHEREAS, the Pisinemo District Council is continuing to examine the fiscal requirements of all**  
4 **operations, projects and services; and**

5 **WHEREAS, it is in the best interest of the Pisinemo District to request Legislative Council to enact**  
6 **necessary authority to permit Pisinemo District to continue use of funds budgeted for**  
7 **operations, projects and services beyond September 30, 2007.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
9 **approves a Continuing Resolution for Pisinemo District's FY 2007 budget; sufficient**  
10 **funds are available within the Pisinemo District's FY 2007 budget to cover**  
11 **expenditures beyond September 30, 2007.**

12 **BE IT FURTHER RESOLVED that all employees compensation shall remain at current levels until**  
13 **such time that the District's fiscal year 2008 budget is formally adopted and**  
14 **authorizes any necessary employee compensation adjustments to be retroactive to**  
15 **October 1, 2007.**

16 **BE IT FINALLY RESOLVED that the Continuing Resolution will stay in effect until the Pisinemo**  
17 **District presents its FY 2008 Budget to the Legislative Council for review and**  
18 **approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup>. Day**  
20 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and 199.2 [07] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1(d)(2) & (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
23 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**




