

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Sif-Oidak District FY 2008 Mining Budget)**

**RESOLUTION NO. 07-647**

1 **WHEREAS, the Sif-Oidak District Council convened a special meeting on Wednesday, September**  
2 **19, 2007 to finalize the FY 2008 Mining Budget; and**

3 **WHEREAS, by Resolution No. 09-07-26, the Sif-Oidak District Council approved the FY 2008**  
4 **Mining Budget in the amount of \$629,900.00; and**

5 **WHEREAS, on September 20, 2007, the Sif-Oidak District Administration presented the FY 2008**  
6 **Mining Budget to the Tohono O'odham Legislative Budget and Finance Committee for**  
7 **their review and recommendations.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
9 **approve the Sif-Oidak District FY 2008 Mining Budget in the amount of \$629,900.00.**

10 **BE IT FURTHER RESOLVED that the funds will be taken out of the General Fund Investment**  
11 **Account.**

12 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the**  
13 **attached Budget shall be submitted for further prior approval by the Tohono**  
14 **O'Odham Legislative Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
16 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,072.75 FOR; -0-**  
17 **AGAINST; 262.55 NOT VOTING; and 199.2 [07] ABSENT, pursuant to the powers vested in the Council**  
18 **by Section 1(d)(2) & (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
19 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**


