(Approving the FY08 Budget for the Hikiwan District Administration for Operations,
\$982,981.78; and Seven Communities in the amount of \$210,000; and Depositing Host
Share in the amount of \$14,881.26 into Bank of America Savings)**

RESOLUTION NO. 07-648

1 **WHEREAS, the Hikiwan District Council presented their FY08 Budgets to the Tohono O'Odham**
2 **Legislative Council for approval in the amount of \$1,192,981.78 for Administrative**
3 **Operations and Seven Communities of the District, from Gaming Distribution/Host**
4 **Share of \$1,207,863.04; and**

5 **WHEREAS, the Hikiwan District Council has approved the FY08 Budget for the District**
6 **Administration for Operation costs at \$982,981.78; and**

7 **WHEREAS, the Seven Communities (Ge'hakah, Hikiwan, Hodai Son Vo, Schuchuligk, S-tuha**
8 **Bidag, Vaya Chin, and Ventana) has also presented their FY08 Budgets in the amount**
9 **of \$210,000 at \$30,000 per community for approval; and**

10 **WHEREAS, the Hikiwan District Council recommends the amount of \$14,881.26 from the Gaming**
11 **Distribution/Host Share for deposit into the Savings Account of the Hikiwan District.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'Odham Legislative Council hereby**
13 **approves the Hikiwan District Administration FY08 Budget in the amount of**
14 **\$1,192,981.78 for Operations and Seven Communities.**

15 **BE IT FINALLY RESOLVED THAT the Tohono O'Odham Legislative Council hereby approves**
16 **depositing the Host Share of \$14,881.26 into the Savings Account of the Hikiwan**
17 **District.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24th Day**
19 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 1,640.8 FOR; 407.45**
20 **AGAINST; 287.05 NOT VOTING; and 199.2 [07] ABSENT, pursuant to the powers vested in the Council**
21 **by Section 1(d)(2) & (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
22 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
