

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Clark Law Firm, P.C.)

RESOLUTION NO. 07-649

1 **WHEREAS, it is advisable that the Tohono O'odham Justice Center has available independent**
2 **legal representation for employment issues in which the Court Solicitor is unable to**
3 **provide legal advice due to conflicts of interest; and**

4 **WHEREAS, the Justice Center recommends an Attorney Contract with the Clark Law Firm, P.C.**
5 **(the "Attorneys") to provide legal representation to the Justice Center for the**
6 **foregoing purposes; and**

7 **WHEREAS, the proposed Attorney Contract is for fiscal year 2008 and begins October 1, 2007 and**
8 **ends September 30, 2008; and**

9 **WHEREAS, the proposed Attorney Contract is in the amount of \$25,000 for fiscal year 2008; and**

10 **WHEREAS, the anticipated operating budget for the Justice Center (Account No. 01-1032-810) for**
11 **fiscal year 2008 includes sufficient funds for the Attorney Contract; and**

12 **WHEREAS, the Judiciary Committee, the Domestic Affairs Committee, and the Budget and**
13 **Finance Committee have reviewed the contract and recommend approval by the**
14 **Legislative Council for the Attorney Contract.**

15 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 16 **1. The Tohono O'odham Legislative Council does hereby approve the Attorney**
17 **Contract with the Clark Law Firm in the amount of \$25,000 for fiscal year 2008,**
18 **beginning October 1, 2007 and ending September 30, 2008 and in substantially**
19 **the form attached hereto.**
- 20 **2. Subject to Legislative Council approval of the Judicial Branch budget, funding for**
21 **the Attorney Contract in fiscal year 2008 shall be provided under the operating**
22 **budget of the Justice Center (Account No. 01-1032-810).**
- 23 **3. The Chief Judge of the Justice Center is authorized and directed to execute the**
24 **Attorney Contract.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
26 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and 199.2 [07] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1(f) and Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation,**
29 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
31 **of June 18, 1934 (48 Stat. 984).**
