

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the 3<sup>rd</sup> Year Funding at \$143,679.94 for the Multi-year Grant Under the  
Bureau of Justice Administration, Indian Alcohol and Substance Abuse Program  
Grant Award No. 2005-AC-BX-0005)**

**RESOLUTION NO. 07-650**

1 **WHEREAS, on March 13, 2006, the Tohono O'odham Legislative Council approved the three-year**  
2 **Indian Alcohol and Substance Abuse Media Message and Public Information**  
3 **Campaign Program Grant, grant award number 2005-AC-BX-0005, awarded to the**  
4 **Tohono O'odham Nation Justice Center with a total budget of \$500,000.00; and**

5 **WHEREAS, the program will provide intervention and prevention programs to assist in the**  
6 **education and awareness of alcohol and substance abuse-related juvenile crimes;**  
7 **traffic fatalities and injuries; produce culturally relevant anti-alcohol/anti-drug**  
8 **media messages for the Nation; enlist support and involvement of the Nation's**  
9 **citizens, law enforcement personnel, and other relevant agencies on behalf of at-risk**  
10 **youth; and**

11 **WHEREAS, the federal fiscal year for 2008 runs from July 1, 2007 to June 30, 2008 with a budgeted**  
12 **base grant amount of \$122,698.50; and**

13 **WHEREAS, the grant agency has set the Indirect Cost rate at 17.10%, which totals \$20,981.44, the**  
14 **new budget for FY 2008 totals \$143,679.94; and**

15 **WHEREAS, these funds are necessary for the continued development and implementation of an**  
16 **alcohol and substance abuse media and public information campaign; and**

17 **WHEREAS, this Indian Alcohol and Substance Abuse Grant Budget for FY 2008 has been reviewed**  
18 **and approved by the Tohono O'odham Nation's Grants and Contracts department;**  
19 **and**

20 **WHEREAS, this Indian Alcohol and Substance Abuse Grant Budget for FY 2008 has been reviewed**  
21 **by the Tohono O'odham Judiciary and Budget and Finance Committees.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
23 **approve the Justice Center Indian Alcohol and Substance Abuse Media Message and**  
24 **Public Information Campaign Grant award number 2005-AC-BX-0005 which is a three**  
25 **(3) year grant beginning July 1, 2005 to June 30, 2008 in the combined amount of**  
26 **\$500,000.00; and approves the FY 2008 budget in the amount of \$143,679.94, which**  
27 **includes a \$20,981.44 difference in Indirect Cost as approved by the funding agency.**

28 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
29 **Chief Judge to negotiate and execute the contracts and plans, provided, however, that**
