(Approval to accept an agreement between the Tohono O'odham Nation and US Bureau
of Land Management and to accept a grant award of \$14,000 for the Undocumented
Migrant Waste Clean-up Project)

RESOLUTION NO. 07-651

1 **WHEREAS, the Tohono O'odham Nation and the US Bureau of Land Management will enter into**
2 **an agreement that will provide a grant award of \$14,000 for the Undocumented**
3 **Migrant Waste Clean-up Project; and**

4 **WHEREAS, this agreement between the Tohono O'odham Nation and the US Bureau of Land**
5 **Management has been reviewed by the Tohono O'odham Legislative Natural**
6 **Resources, Domestic Affairs, and the Budget and Finance Committees.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
8 **approves:**

- 9 **1. the acceptance of the agreement between the Tohono O'odham Nation and the US**
10 **Bureau of Land Management; and**
11 **2. the acceptance of a grant award of \$14,000 for the Undocumented Migrant Waste**
12 **Clean-up Project.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Natural Resources Department Solid Waste**
14 **Management Program shall return with a budget after the agreement has been**
15 **executed.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
17 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,163.3 FOR; -0-**
18 **AGAINST; 172.0 NOT VOTING; and 199.2 [08] ABSENT, pursuant to the powers vested in the Council**
19 **by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
