## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving a SAWRSA Trust Fund Budget for the Office of Attorney General for Professional Services)

RESOLUTION NO. <u>07-653</u>

1	WHEREAS, the Tohono O'odham Nation requires the legal services of a lobbyist in Washington,
2	D.C. to assist the Nation in obtaining an amendment to the Arizona Water Settlements
3	Act of 2004, and has entered into an attorney contract with Paul Moorehead of the law
4	firm of Drinker, Biddle and Reath, LLP, beginning on July 17, 2007, for this purpose;
5	and
6	WHEREAS, by Resolution No. 07-441, the Legislative Council appropriated \$50,000 from the
7	interest on the SAWRSA trust fund to fund the attorney contract with Paul Moorehead;
8	and
9	WHEREAS, a new budget account for professional services paid from the SAWRSA trust fund is
10	needed in order to pay the invoices from Drinker, Biddle & Reath which have
11	accumulated since July 2007; and
12	WHEREAS, the Water Resources, Domestic Affairs and Budget & Finance Committees have
13	reviewed this budget and recommend approval by the Legislative Council.
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
15	creation of a new budget account for the Office of Attorney General for professional
16	services, funded from the SAWRSA trust fund, in the initial amount of \$50,000, and
17	authorizes the program to expend the funds as provided in the budget.
18	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24 <sup>TH</sup> . Day
19 20	of <u>SEPTEMBER, 2007</u> at a meeting at which a quorum was present with a vote of <u>2,335.3</u> FOR; <u>-0-</u> AGAINST; -0- NOT VOTING; and <u>199.2</u> [07] ABSENT, pursuant to the powers vested in the Council by
21	Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
22	Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24	18, 1934 (48 Stat. 984).
