

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving New Account for One Stop Division's P.L. 102-477 Grant)**

RESOLUTION NO. 07-654

1 **WHEREAS, pursuant to Resolution No. 07-035, the Tohono O'odham Legislative Council approved**
2 **the One Stop Division of Bureau of Indian Affairs - 477 Budget for FY2007; and**

3 **WHEREAS, the Grants and Contracts Department requested the Nation to establish a new interest**
4 **bearing account for the purpose of segregating the interest earned from the One Stop**
5 **Division's P.L. 102-477 grant from other Nation accounts and for the purpose of**
6 **drawing down of funds; and**

7 **WHEREAS, pursuant to Article VI of the Constitution of the Tohono O'odham Nation, the Tohono**
8 **O'odham Legislative Council has the authority to manage funds within the exclusive**
9 **control of the Tohono O'odham Nation (Constitution, Article VI, Section 1(d)(2)).**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
11 **authorizes the Nation's Office of the Treasurer to establish a new interest bearing**
12 **account with Bank of America for the purpose of segregating the interest earned from**
13 **the One Stop Division's P.L. 102-477 grant from other Nation accounts and for the**
14 **purpose of drawing down of funds.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
16 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and 199.2 [07] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
