11	authorizes the Nation's Office of the Treasurer to establish a new interest bearing
12	account with Bank of America for the purpose of segregating the interest earned from
13	the One Stop Division's P.L. 102-477 grant from other Nation accounts and for the
14	purpose of drawing down of funds.
