

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sells District FY 2008 Budget Amendment No. 1)

RESOLUTION NO. 07-655

1 **WHEREAS, the Sells District Chairperson and Treasurer presented the Sells District FY-2008**
2 **Budget Amendment to the Tohono O'odham Legislative Council; and**

3 **WHEREAS, the FY-2008 Budget is in the amount of One Million, One Hundred Ninety Two**
4 **Thousand, Nine Hundred Eighty One Dollars and Seventy Eight Cents (\$1,192,981.78);**
5 **and**

6 **WHEREAS, the FY 08 Administration Budgets is amended to use the FY 2007 salary table as the**
7 **base budget and add the 2.5 increase for FY 2008; line item 610 and 620; and**

8 **WHEREAS, the Tohono O'odham Legislative Budget and Finance and the Tohono O'odham**
9 **Legislative Council did review and approve the Sells District Administrative Budget**
10 **Amendment.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
12 **Sells District FY 08 Budget Amendment according to the budgets attached hereto.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
14 **Chairperson and any designated official to expend and administer the budget, as**
15 **attached, provided that any modifications/amendments affecting the funds or funding**
16 **levels of the budget shall be submitted for further prior approval by the Tohono**
17 **O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
19 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 199.2 [07] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1(d)(2)and(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
22 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
