1 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above named applicant  
2 is eligible for enrollment as a member of the Tohono O'odham Nation under Section  
3 1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation, and that  
4 their application is approved, as herein above indicated.

5 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Tohono  
6 O'odham Nation reduce this final determination in writing regarding each of the  
7 foregoing applications for enrollment in accordance with Section 1(a) of Article XIII  
8 of the Enrollment Ordinance; give notice of this Council's determination in  
9 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place the  
10 names of each applicant upon the membership roll of the Tohono O'odham Nation  
11 in accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.

12 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 08<sup>TH</sup> Day  
13 of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 1,007.0 FOR; 977.65  
14 AGAINST; 549.85 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
15 Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham  
16 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting  
17 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
18 of the Act of June 18, 1934 (48 Stat. 984).
