1 **WHEREAS, David Fazzino is currently a student at the University of Florida in Gainesville, Florida**
2 **completing his Doctorate in Anthropology, of which the final requirement is a**
3 **dissertation; and**

4 **WHEREAS, David Fazzino presented his research proposal entitled *Tohono O'odham Traditional***
5 ***Food: Conservation and Utilization of Seeds as Sources of Identity, Meaning, Health***
6 ***and Culture* to the Tohono O'odham Legislative Council June 10, 2005; and**

7 **WHEREAS, the Tohono O'odham Legislative Council on June 10, 2005 approved Mr. Fazzino's**
8 **research proposal by Resolution No. 05-338; and**

9 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 05-338 was vetoed by Chairwoman**
10 **Vivian Juan-Saunders on June 20, 2005; and**

11 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 05-351 overriding Vetoed**
12 **Resolution No. 05-338, approved Mr. Fazzino's research proposal; and**

13 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 05-338 required that Mr. Fazzino**
14 **submit a copy of the final report to the Tohono O'odham Legislative Council; and**

15 **WHEREAS, Mr. Fazzino has completed his research project and is submitting his final report**
16 **entitled; *Traditional Foods on the Tohono O'odham Nation with Focus on San Lucy* to**
17 **the Tohono O'odham Legislative Council; and**

18 **WHEREAS, Mr. Fazzino's report contains important information on Tohono O'odham traditional**
19 **foods provided in a Tohono O'odham voice through many interview with members of**
20 **the Tohono O'odham Nation; and**

21 **WHEREAS, Mr. Fazzino's report contains important information related to Tohono O'odham diet**
22 **and health issues.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does accept and**
24 **approve Mr. Fazzino's final report entitled *Traditional Foods on the Tohono O'odham***
25 ***Nation with Focus on San Lucy.***

26 **BE IT FINALLY RESOLVED that copies of Mr. Fazzino's report entitled: *Traditional Foods on***
27 ***the Tohono O'odham Nation with Focus on San Lucy* should be placed in the following**
28 **locations on the Tohono O'odham Nation; the San Xavier Cooperative Farm, the**
29 **Tohono O'odham Community Action group, District Offices, the Cultural Center**
30 **Museum, the Community College, schools, the Venito Garcia Library and health**
31 **facilities. In addition, copies should be provided to the Tucson Indian Center, the**
