

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Approving a one time request for the Tohono O'odham Nation Fire Department to purchase an aerial ladder truck, service vehicle, and command vehicle and to fund initial cost to support new positions and the construction of a permanent facility)

RESOLUTION NO. 07-670

1 **WHEREAS, the Tohono O'odham Nation Department of Public Safety Fire Department has**
2 **deemed it critical and necessary to increase Fire Protection services to the Tohono**
3 **O'odham Nation, particularly the new Desert Diamond Casino/Hotel; and**

4 **WHEREAS, the Fire Department's current fleet of apparatus does not include an aerial**
5 **apparatus (ladder truck) necessary to immediately support emergency operations,**
6 **primarily rescue; and**

7 **WHEREAS, the Fire Department requires an additional command vehicle and service vehicle**
8 **to support new resources and positions; and**

9 **WHEREAS, the Fire Department must also support the initial cost associated with new positions**
10 **and must construct a facility to house additional resources.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
12 **use of gaming savings by the Tohono O'odham DPS-Fire Department for a one time**
13 **appropriation of \$4,055,700.00 to purchase a ladder truck, other emergency**
14 **response vehicles and to construct a fire/police substation and provide for initial**
15 **cost associated with new positions in accordance with the budget attached hereto.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
17 **Chairman and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level shall**
19 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
21 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 1,844.65 FOR; 689.85**
22 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
