

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing FY 2008 Expenditures from the SAWRSA Trust Fund for Continuation of**  
**Efforts to Complete Tribal Responsibilities and Obligations Related to Utilization of**  
**Central Arizona Project Water and Irrigation Systems)**

**RESOLUTION NO. 07-676**

1 **WHEREAS, the Tohono O'odham Legislative Council, by means of Resolution No. 99-334,**  
2 **authorized and directed the completion of tribal responsibilities and obligations**  
3 **related to construction of facilities for utilization of Central Arizona Project water and**  
4 **irrigation systems in the eastern Schuk Toak District; and**

5 **WHEREAS, portions of work identified for FY 2007 were not completed and are being budgeted for**  
6 **in FY 2008 as reflected in the attached budget and justification; and**

7 **WHEREAS, the Water Projects Office submitted the attached budget and justification for FY 2008**  
8 **to continue the scope of work authorized under Resolution No. 99-334 for an amount**  
9 **of \$112,339.36; and**

10 **WHEREAS, the Water Projects Office requests from the Tohono O'odham Legislative Council,**  
11 **approval of funding from the SAWRSA Trust Fund to enable completion of tribal**  
12 **responsibilities and obligations related to utilization of Central Arizona Project water**  
13 **and irrigation systems in the eastern Schuk Toak District.**

14 **NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
15 **approves the funding request and authorizes the expenditures in the amount of**  
16 **\$112,339.36 to complete tasks indicated in the attached budget for the fiscal year 2008.**

17 **BE IT FURTHER RESOLVED that funds in the amount of \$112,339.36 are hereby appropriated from**  
18 **the SAWRSA Trust Fund to cover expenditures during the period from October 01, 2007**  
19 **through September 30, 2008 and the FY2008 budget is retroactive to October 01, 2007.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
21 **Chairperson and any designated official to expend and administer the budget as**  
22 **attached, provided that any amendments affecting the funds or funding level shall be**  
23 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
25 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
