

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Mandating Legislative Council Representatives' Attendance at Public Hearings)**

**LEGISLATIVE ORDER NO. 07-677**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**

5 **WHEREAS, Article I, Section 1.E., of the Legislative Rules of the Tohono O'odham Legislative**  
6 **Council require that the Council conduct public hearings every four years as follows:**

- 7 1. **During the first general session following the 2007 general election, and every**  
8 **four years thereafter, the Legislative Council shall schedule and conduct public**  
9 **hearings to collect input from the membership to set goals and objectives for the**  
10 **Tohono O'odham Nation, and to report to the membership the status of the**  
11 **previous goals and objectives.**  
12  
13 2. **All Legislative Council representatives shall attend such public hearings.**  
14  
15 3. **Four public hearings shall be scheduled to cover the Tohono O'odham Nation.**  
16  
17 4. **The minutes of the public hearings shall be presented to the Legislative Council**  
18 **for review and action within three months of the last public hearing.**

19 **WHEREAS, the Legislative Council will begin conducting such public hearings on October 16,**  
20 **2007.**

21 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that:**

- 22  
23 (1) **in accordance with Article I, Section 1.E.2., of the Legislative Rules of the Tohono**  
24 **O'odham Legislative Council, Legislative Council representatives are mandated**  
25 **to attend the Council's 2007 public hearings; and**  
26  
27 (2) **such public hearings shall be deemed "sessions" for purposes of the Legislative**  
28 **Council Session Attendance Rules, which shall govern Council representatives'**  
29 **attendance at the public hearings.**

31 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>. Day of**  
32 **OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
33 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**  
34 **VI, Section 1(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
35 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
36 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
37 **Stat. 984).**
