## LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Mandating Legislative Council Representatives' Attendance at Public Hearings)

	LEGISLATIVE ORDER NO. <u>07-677</u>
1	WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to
2	regulate all meetings of the Tohono O'odham Council, standing committees, boards
3	and special committees." (Constitution of the Tohono O'odham Nation, Article VI,
4	Section 1(a)); and
5	WHEREAS, Article I, Section 1.E., of the Legislative Rules of the Tohono O'odham Legislative
6	Council require that the Council conduct public hearings every four years as follows:
7 8 9 10 11 12	<ol> <li>During the first general session following the 2007 general election, and every four years thereafter, the Legislative Council shall schedule and conduct public hearings to collect input from the membership to set goals and objectives for the Tohono O'odham Nation, and to report to the membership the status of the previous goals and objectives.</li> </ol>
13	2. All Legislative Council representatives shall attend such public hearings.
14 15 16	3. Four public hearings shall be scheduled to cover the Tohono O'odham Nation.
10 17 18	4. The minutes of the public hearings shall be presented to the Legislative Council for review and action within three months of the last public hearing.
19	WHEREAS, the Legislative Council will begin conducting such public hearings on October 16,
20	2007.
21 22	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that:
23 24 25 26	(1) in accordance with Article I, Section 1.E.2., of the Legislative Rules of the Tohono O'odham Legislative Council, Legislative Council representatives are mandated to attend the Council's 2007 public hearings; and
27 28 29 30	(2) such public hearings shall be deemed "sessions" for purposes of the Legislative Council Session Attendance Rules, which shall govern Council representatives' attendance at the public hearings.
31 32 33 34 35 36	The foregoing Order was passed by the Tohono O'odham Legislative Council on the <u>12<sup>TH</sup></u> . Day of <u>OCTOBER</u> , <u>2007</u> at a meeting at which a quorum was present with a vote of <u>2,534.5</u> FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and [ <u>01</u> ] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1( <u>a</u> ) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
