

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract for FY2008 with Chandler & Udall LLP and Approving
Budget Amendment No. 1 to Budget Number 21-2010)

RESOLUTION NO. 07-693

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Steve**
2 **Weatherspoon at the law firm of Chandler & Udall LLP to assist the Tohono O'odham**
3 **Nation in the development of the Nation's water codes and the implementation of**
4 **SAWRSA, preparation of regulations for the water codes, and providing written**
5 **explanations of the water codes in common English format; and**

6 **WHEREAS, the Attorney General recommends an attorney contract with Chandler & Udall LLP**
7 **in the amount of \$150,000.00 for Fiscal Year 2008, for the period October 1, 2007 to**
8 **September 30, 2008; and**

9 **WHEREAS, funding for the attorney contract will be from the SAWRSA Trust Fund, account**
10 **number 21-2010 which has been established for water-related attorney contracts**
11 **under the Office of Attorney General; and**

12 **WHEREAS, the Office of Attorney General has proposed Budget Amendment No. 1 to budget**
13 **number 21-2010 in the amount of \$150,000.00 to fund the attorney contract; and**

14 **WHEREAS, the Domestic Affairs, Water Resources and Budget & Finance Committees have**
15 **reviewed the attorney contract and Budget Amendment No. 1 and recommend**
16 **approval by the Legislative Council.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 18 **1. Approves the Attorney Contract with Chandler & Udall in the amount of**
19 **\$150,000.00 for Fiscal Year 2008, for the period October 1, 2007 to September 30,**
20 **2008, substantially in the form attached hereto.**
- 21 **2. Approves Budget Amendment No. 1 for budget number 21-2010 in the amount of**
22 **\$150,000.00, and appropriates \$150,000.00 from the SAWRSA Trust Fund to fund**
23 **the budget amendment, providing a total budget of \$200,000.00.**
- 24 **3. Funding for the Attorney Contract shall be from the budget of the Office of**
25 **Attorney General (budget number 21-2010).**
- 26 **4. The Chairperson of the Nation is authorized and directed to execute the Attorney**
27 **Contract.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
29 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
31 **Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**


