

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for Six Months in FY2008 with the Law Office of James D. Hill)

RESOLUTION NO. 07-694

1 **WHEREAS, the Office of Attorney General continues to require the legal services of James D. Hill**
2 **on a part time basis in areas of natural resources and environmental law and in**
3 **general tribal legal matters; and**

4 **WHEREAS, the Office of Attorney General has proposed a budget of \$39,000.00 for a six month**
5 **period, from October 1, 2007 to March 31, 2008; and**

6 **WHEREAS, the Domestic Affairs and the Budget & Finance Committees have reviewed the**
7 **attorney contract and recommend approval by the Legislative Council.**

8 **WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of**
9 **Attorney General (01-1031-810).**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with**
12 **the Law Office of James D. Hill in the amount of \$39,000.00 for the period October**
13 **1, 2007 to March 31, 2008, substantially in the form attached hereto.**
- 14 **2. Funding for the Attorney Contract shall be provided from the budget of the Office**
15 **of Attorney General (01-1031-810).**
- 16 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day**
19 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
