WHEREAS, the Office of Attorney General has proposed a budget of \$39,000.00 for a six month period, from October 1, 2007 to March 31, 2008; and

WHEREAS. the Domestic Affairs and the Budget & Finance Committees have reviewed the attorney contract and recommend approval by the Legislative Council.

WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of Attorney General (01-1031-810).

NOW, THEREFORE, BE IT RESOLVED THAT:

- The Tohono O'odham Legislative Council approves the Attorney Contract with the Law Office of James D. Hill in the amount of \$39,000.00 for the period October 1, 2007 to March 31, 2008, substantially in the form attached hereto.
- 2. Funding for the Attorney Contract shall be provided from the budget of the Office of Attorney General (01-1031-810).
- The Chairperson of the Nation is authorized and directed to execute the Attorney Contract.

Day of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
