

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Attorney Contract for FY2008 with Paul J. Matte III)**

**RESOLUTION NO. 07-695**

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Paul J. Matte**  
2 **III to represent the Tohono O'odham Nation in legal proceedings in Maricopa County,**  
3 **Arizona, involving the Nation's interests under the Indian Child Welfare Act; and**

4 **WHEREAS, the Attorney General recommends an Attorney Contract with Paul J. Matte III in the**  
5 **amount of \$35,000 for Fiscal Year 2008, for the period October 1, 2007 to September**  
6 **30, 2008; and**


7 **WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed the attorney**  
8 **contract and recommend approval by the Legislative Council.**

9 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 10           1. **The Tohono O'odham Legislative Council approves the Attorney Contract with**  
11           **Paul J. Matte III in the amount of \$35,000 for Fiscal Year 2008, for the period**  
12           **October 1, 2007 to September 30, 2008, substantially in the form attached hereto.**  
13           2. **Funding for the Attorney Contract shall be from the budget of the Office of**  
14           **Attorney General (Account No. 01-1031-810).**  
15           3. **The Chairperson of the Nation is authorized and directed to execute the Attorney**  
16           **Contract.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup>. Day**  
18 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
23 **Stat. 984).**


