

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Attorney Contract For FY2008 with California Indian Legal Services)**

RESOLUTION NO. 07-696

1 **WHEREAS, the Office of Attorney General continues to require the legal services of California**  
2 **Indian Legal Services to represent the Tohono O'odham Nation in legal proceedings**  
3 **in California involving the Nation's interests under the Indian Child Welfare Act; and**  
4 **WHEREAS, the Attorney General has proposed an attorney contract with California Indian Legal**  
5 **Services for Fiscal Year 2008, for the period October 1, 2007 to September 30, 2008, in**  
6 **the amount of \$100,000; and**  
7 **WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed the attorney**  
8 **contract and recommend approval by the Legislative Council.**

9 **NOW THEREFORE, BE IT RESOLVED THAT:**

- 10           **1. The Tohono O'odham Legislative Council approves an Attorney Contract with**  
11 **California Indian Legal Services in the amount of \$100,000 for Fiscal Year 2008, for**  
12 **the period October 1, 2007 to September 30, 2008, substantially in the form**  
13 **attached hereto.**  
14           **2. Funding for the Attorney Contract shall be provided from the operating budget**  
15 **of the Office of Attorney General.**  
16           **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**  
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> Day**  
19 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**




