

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract for FY2008 with the Law Firm of Yoder & Langford, P.C.,**  
**Relating to Internal Revenue Service Audits)**

RESOLUTION NO. 07-697

1 WHEREAS, the Office of Attorney General continues to require the legal services of Yoder &  
2 Langford, P.C., to represent the Tohono O'odham Nation in matters involving Internal  
3 Revenue Service audits and investigations of the Districts and the Nation; and

4 WHEREAS, the Attorney General has recommended a budget of \$50,000 for fiscal year 2008, for  
5 the period from October 1, 2007 to September 30, 2008; and

6 WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of  
7 Attorney General, account number 01-1031-810; and


8 WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney  
9 contract and recommend approval by the Legislative Council.

10 NOW, THEREFORE, BE IT RESOLVED THAT:

- 11 1. The Tohono O'odham Legislative Council approves the Attorney Contract with the  
12 law firm of Yoder & Langford in the amount of \$50,000.00 for FY2008, for the  
13 period from October 1, 2007 to September 30, 2008, substantially in the form  
14 attached hereto.
- 15 2. Funding for the Attorney Contract shall be provided from the budget of the Office  
16 of Attorney General (01-1031-810).
- 17 3. The Chairperson of the Nation is authorized and directed to execute the Attorney  
18 Contract.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> Day  
20 of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-  
21 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
22 Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
23 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
25 Stat. 984).


