

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Pisinemo District FY 2008 Budget and Authorizing Carryover funds
in the amount of \$25,830.36)**

RESOLUTION NO. 07-698

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 07-461 approves and authorizes**
2 **the FY 2008 apportionment of gaming revenues to the districts by equal distributions**
3 **among the 11 districts of the Nation; and**

4 **WHEREAS, a draft FY 2008 budget in the amount of \$1,218,812.14 was presented to the Pisinemo**
5 **District Council for review, comment and recommendations; and**

6 **WHEREAS, the draft FY 2008 budget was also taken out to the communities of San Simon,**
7 **Pisinemo, Santa Cruz, Kupk and Dirtburn for review and comments and brought**
8 **back to the Pisinemo District Council for action; and**

9 **WHEREAS, both Santa Cruz and Pisinemo communities have requested to use FY 2007 carry over**
10 **funds to supplement its community budgets; and**

11 **WHEREAS, both requests were approved by their respective communities and the Pisinemo**
12 **District Council has confirmed that sufficient funds are available within the Districts**
13 **account to cover both requests; and**

14 **WHEREAS, the FY 2008 budget is distributed as follows:**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
24 **the use of \$25,830.36 from FY-2007 Pisinemo District Carryover funds to be divided**
25 **between Santa Cruz Community in the amount of \$15,830.36 and Pisinemo**
26 **Community in the amount of \$10,000.00.**

27 **BE IT FURTHER RESOLVED that the amount of \$25,830.36 from FY-2007 Pisinemo District**
28 **Carryover funds be added to the \$1,192,981.78 from FY-08 Gaming Distributions per**
29 **district for a total budget of \$1,218,812.14 for Pisinemo District.**

30 **BE IT FINALLY RESOLVED that Tohono O'odham Legislative Council does approve the Pisinemo**
31 **District FY 2008 Operating Budget in the amount of \$1,218,812.14 and authorizes any**
32 **necessary employee compensation to be retroactive to October 1, 2007.**




