

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Use of 2005 Mining Royalties Carryover Funds for FY 08)**

**RESOLUTION NO. 07-699**

1 **WHEREAS, at a regularly scheduled meeting of the Pisinemo District Council a proposal to use**  
2 **FY 05 Mining Royalty carry over funds for FY 08 housing renovations was presented;**  
3 **and**

4 **WHEREAS, Pisinemo District Council was provided a copy of the proposed budget outlining three**  
5 **renovation projects for review and comment; and**

6 **WHEREAS, the Pisinemo District Council is aware of the housing conditions and damages made**  
7 **to some of the homes during recent heavy storms; and**

8 **WHEREAS, the total amount of \$30,300.00 is based on remaining balances from FY 05 Mining**  
9 **Royalties distributed to Pisinemo District.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
11 **and supports the Pisinemo District's request to use FY 2005 Mining Royalty carry over**  
12 **funds in the amount of \$30,300.00 for FY 08 housing renovation projects.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> Day**  
14 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**


