

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Department of Health and Human Services FY 2007 BIA Social Services  
10-1300 Budget Amendment #2 and FY 2007 BIA Children's Home Program 10-1305  
Budget Amendment #3)**

**RESOLUTION NO. 07-701**

**WHEREAS, by Resolution No. 06-212, the Legislative Council approved the Department of Health and Human Services FY 2007 BIA Social Services 10-1300 Budget and FY 2007 BIA Children's Home Program 10-1305 Budget, subject to later approval by the Legislative Council of annual funding agreements with the Bureau of Indian Affairs, and subject to Congressional appropriation of funding in FY 2007 or Continuing Resolution, in the following amounts:**

**WHEREAS, the Nation was notified of an increase of BIA WAG funds via Contract Modification #35 at \$717,918.00, and Contract Modification #41 at \$628,267.00, totaling \$1,346,085.00; and**

**WHEREAS, the Department of Health and Human Services has prepared the attached FY 2007 BIA Social Services 10-1300 Budget Amendment #2, which incorporates amounts in operations line items; and has prepared the attached FY 2007 BIA Children's Home Program 10-1305 Budget Amendment #3, which changes amounts in salary and operations line items; and has presented these to the Tohono O'odham Legislative Council Committees in the following amounts:**

5 **Legislative Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup>. Day**  
7 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
8 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
9 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
10 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
12 **Stat. 984).**


