

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 07-434 and Accepting the increase of \$1,000.00 in the contract
between the Nation and EEOC and Approving the Tohono O'odham Tribal Employment
Rights Office FY 2007 Budget Modification/Amendment No. 3 and EEOC FY 2007 Budget
Modification/Amendment No. 2)**

RESOLUTION NO. 07-702

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since**
2 **1978; and**

3 **WHEREAS, the continued operation of the Tribal Employment Rights Office is to increase**
4 **employment of Indians on and near the Tohono O'odham Nation by enforcing Indian**
5 **Preference in employment, training, contracting, subcontracting and eradicate**
6 **employment discrimination within the exterior boundaries of the Tohono O'odham**
7 **Nation; and**

8 **WHEREAS, the funding for the Tohono O'odham Nation Tribal Employment Rights Office is**
9 **annually supplemented by the United States Equal Employment Opportunity**
10 **Commission through a contract in the amount of \$25,000.00; and**

11 **WHEREAS, in FY 2007 the contract between the Equal Employment Opportunity Commission and**
12 **the Tohono O'odham Tribal Employment Rights Office increased from \$25,000.00 to**
13 **\$26,000.00; and**

14 **WHEREAS, the contract between the Equal Employment Opportunity Commission and the Tohono**
15 **O'odham Tribal Employment Rights Office has been approved by the Office of the**
16 **Chairman; and**

17 **WHEREAS, the contract between the Equal Employment Opportunity Commission and the Tohono**
18 **O'odham Tribal Employment Rights Office requires the Tohono O'odham Nation to**
19 **accept contract funds without withholding indirect costs; and**

20 **WHEREAS, by Resolution No. 07-434, the Legislative Council approved Modification/Amendment**
21 **No. 2 to the TERO FY 2007 Budget and Modification/Amendment No. 1 to the TERO-**
22 **EEOC budget, but those Modifications/Amendments failed to account for indirect**
23 **costs.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
25 **accepts the increase of \$1,000.00 in the contract between the EEOC and the Tohono**
26 **O'odham Nation without withholding indirect costs.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council rescinds Resolution No.**
28 **07-434 and the two Modifications/Amendments that it approved and accepts the**
29 **increase of \$1,000.00 in the contract between the Nation and EEOC and approves the**

3 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves and**
4 **adopts the supplemental funding for the Tribal Employment Rights Office FY 2007**
5 **Equal Employment Opportunity Commission Budget in the amount of \$1,000.00 by**
6 **increasing the EEOC budget line item 610-Salaries by \$3,671.73 and line item 620-**
7 **Fringe Benefits by \$1,138.24 and deleting line item 900-Indirect Cost Charges; and**
8 **decreasing the tribal TERO budget line item 610-Salaries by \$3,318.88 and line item**
9 **620-Fringe Benefits by \$1,491.09.**

10 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby waives the**
11 **Indirect Cost requirement from the EEOC Budget.**

12 **BE IT FURTHER RESOLVED that the duration of this grant commences on October 1, 2006 through**
13 **September 30, 2007.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes**
15 **the Chairman and any designated official to expend and administer the budget as**
16 **attached, provided that any amendments affecting the funds or funding level shall be**
17 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day**
19 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,086.3 FOR; 249.0**
20 **AGAINST; -0- NOT VOTING; and 199.2 [05] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**


