RESOLUTION NO. 07-704

1 **WHEREAS, the National Congress of American Indians ("NCAI") will hold its 64th Annual Session**
2 **in Denver, Colorado on November 11-16, 2007; and**

3 **WHEREAS, the Tohono O'odham Nation is a long-time member in good standing with the**
4 **National Congress of American Indians; and**

5 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to renew its membership in the**
6 **National Congress of American Indians.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
8 **it hereby authorizes the following persons to serve as the Tohono O'odham Nation's**
9 **delegation to the National Congress of American Indians 64th Annual Session:**

21 **Ned Norris, Jr., Chairman as the Tohono O'odham Nation's voting delegate and**
22 **Legislative Council Chairperson Verlon Jose to serve as alternate voting delegate to**
23 **the National Congress of American Indians 64th Annual Session.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD. Day**
25 **of OCTOBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
