RESOLUTION NO. 07-719

1	WHEREAS, the Legislative Council is empowered by Article VIII, Section 4 of the Constitution of
2	the Tohono O'odham Nation to appoint judges of the Tohono O'odham Courts; and
3	WHEREAS, the Legislative Council did by Ordinance No. 01-89, Chapter II, authorize the
4	appointment of judges pro tempore to the Tohono O'odham Courts upon the
5	recommendation of the Chief Judge for a term of no greater than six years; and
6	WHEREAS, the Chief Judge has recommended the appointment of Robert A. Hershey, who satisfies
7	the qualifications set forth in 2-103 of Ordinance No. 01-89, as judge pro tempore of
8	the Tohono O'odham Judicial Courts for a six-year term; and
9	WHEREAS, the Judiciary Committee has determined that Robert A. Hershey is of good moral
10	character, a resident of the State of Arizona for not less than five years, and has been
11	admitted to the practice of law for not less than three years; and
12	WHEREAS, the Judiciary Committee concurs with the recommendation of the Chief Judge and
13	recommends that the Legislative Council appoint Robert A. Hershey as judge pro
14	tempore.
15	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it accepts
16	the recommendation of the Chief Judge and hereby appoints Robert A. Hershey as
17	judge pro tempore of the Tohono O'odham Judicial Court for a term beginning
18	November 1, 2007 and ending October 31, 2013.
