

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Xavier District 2008 Fiscal Year Budget)

RESOLUTION NO. 07-721

1 **WHEREAS, the San Xavier District Council reviewed the projected expenditures for its FY08**
2 **budget and determined that the budget components are essential to meeting the**
3 **needs of the San Xavier District Community; and**

4 **WHEREAS, the San Xavier District Council intends to use its gaming and mining revenues to meet**
5 **the projected budget amount outlined in the attached FY08 budget; and**

6 **WHEREAS, the proposed budget in the amount of \$6,887,666.72, and the requested 5% salary**
7 **increase for the District Chairman was reviewed and approved by majority vote of the**
8 **San Xavier District members present at the District Community meeting of October**
9 **13, 2007; and**

10 **WHEREAS, on October 13, 2007 the District Council convened in a special session immediately**
11 **following the District Community meeting and enacted Res. No. SXDC 10-07-04**
12 **approving the FY08 budget; and**

13 **WHEREAS, the San Xavier District (District) officials and staff met with the Legislative Budget &**
14 **Finance Committee (Committee) on October 16, 2007 to review the District's budget**
15 **and supporting resolution; and**

16 **WHEREAS, upon review of the District's budget and resolution, the Committee recommended that**
17 **the San Xavier District Council's resolution be amended to include wording specifying**
18 **the dollar amount of gaming, and mining revenues the District intends to use for its**
19 **FY08 budget; and**

20 **WHEREAS, the San Xavier District Council subsequently amended their resolution as**
21 **recommended by the Committee and re-approved its budget pursuant to Res. No.**
22 **SXDC 10-07-08.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
24 **the San Xavier District FY08 Budget in the amount of \$6,887,666.72 using \$6,802,157.50**
25 **of its gaming revenues and \$85,509.22 of its mining revenues to implement its budget.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
27 **of NOVEMBER, 2007 at a meeting at which a quorum was present with a vote of 1,718.6 FOR; -0-**
28 **AGAINST; 616.7 NOT VOTING; and 199.2 [03] ABSENT, pursuant to the powers vested in the Council**
29 **by Section 1(d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
30 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
