

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the use of Carry Forward Funds from the US Department of Homeland Security,
Office for Domestic Preparedness, 2005 State Homeland Security Grant #2005-GE-T5-0030
for \$4,013.00)

RESOLUTION NO. 07-724

1 **WHEREAS, the United States Department of Homeland Security has distributed grants within the**
2 **program period that was introduced on 10/01/04 to individual states, to fund**
3 **equipment purchases and training by departments that provide public safety services**
4 **within their respective jurisdictions; and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**
6 **requiring tribes to sign a Letter of Offer and Acceptance; and**

7 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer and Acceptance with the**
8 **State of Arizona for the purpose of obligating and distributing funds from the U.S.**
9 **Department of Homeland Security, Office of Domestic Preparedness, Homeland**
10 **Security Grant Program on a reimbursement basis to finance equipment purchases,**
11 **training costs and other needs for homeland security; and**

12 **WHEREAS, the Letter of Offer and Acceptance was approved in the form attached hereto by the**
13 **Tohono O'odham Legislative Council through Resolution 05-489 and subsequently**
14 **signed by the former Chairwoman; and**

15 **WHEREAS, on 12/05/05, the Tohono O'odham Nation was awarded a grant from the Arizona**
16 **Department of Emergency and Military Affairs in the amount of \$4,013.00 as part of the**
17 **2005 grant program for the professional services allowing for priority restoration and**
18 **use of telecommunications in the event of a disaster incident that may affect the**
19 **Tohono O'odham Nation; and**

20 **WHEREAS, in order to complete all projects associated with this grant, the original Line Item 810**
21 **Professional Services will need to be deleted and replaced with Line Item 711**
22 **Communications Expense; and**

23 **WHEREAS, the use of carry forward funds of \$4,013.00 has been reviewed by the Grants &**
24 **Contracts Office, Executive Office, Domestic Affairs Committee and Budget & Finance**
25 **Committee, of which all recommend approval of the carry forward funds by the**
26 **Legislative Council.**


27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
28 **use of carry forward funds of \$4,013.00 from the U.S. Department of Homeland**


