

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution 07-709 to Delete One Name from Payment Schedule No. 86 Listing**  
**of the Per Capita Payment Under the Second Per Capita Plan)**

**RESOLUTION NO. 07-747**

1 **WHEREAS, on November 5, 2007 the Enrollment Office filed with the Tohono O'odham Legislative**  
2 **Council a certification of Eligible Members listing 53 adult members who are eligible**  
3 **for receipt of the Initial Per Capita Distribution; and**

4 **WHEREAS, the Tohono O'odham Legislative Council has accepted and approved certification of**  
5 **eligible members for the initial per capita distribution pursuant to Resolution No. 97-**  
6 **451; and**

7 **WHEREAS, pursuant to Resolution No. 07-709 the Tohono O'odham Legislative Council approved**  
8 **per capita payment of \$2,000.00 for Ruben M. Orduno Jr., Roll No. 1388-GV-88; and**

9 **WHEREAS, due to duplication the listing shall be corrected to delete Ruben M. Orduno Jr. from**  
10 **Payment Schedule No. 86 listing 52 names; and**


11 **WHEREAS, the sum of \$106,000.00 shall change to \$104,000.00 to correct the reduced amount of**  
12 **\$2,000.00 for one member and that the transfer of sum from the per capita account to**  
13 **the special checking account established at Bank of America will commence payment;**  
14 **and**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves to**  
16 **amend Resolution No. 07-709 to delete the name of Ruben M. Orduno Jr.; Roll No. 1388-**  
17 **GV-88 from the listing and to change the Payment Schedule No. 86 listing 52 names and**  
18 **the authorized sum to \$104,000.00 for the Per Capita Payments under the Second Per**  
19 **Capita Plan.**

20 **BE IT FINALLY RESOLVED that Ruben M. Orduno Jr., was listed in the June 5, 2006 Payment**  
21 **Schedule No. 69 and his name shall be deleted from Payment Schedule No. 86 due to**  
22 **duplication.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> Day**  
24 **of DECEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
27 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**






