1	WHEREAS,	the Legislative Council is vested with the power to "employ legal counsel for the
2		protection and advancement of the rights of the Tohono O'odham Nation"
3		(Constitution of the Tohono O'odham Nation, Article VI, Section 2(a)); and
4	WHEREAS,	it is in the Nation's interest to employ a lob by ist in Washington, D.C. in order to protect
5	ı	the Nation's rights on a federal level; to provide advice regarding federal
6		appropriations, legislation, and programs; and, when authorized, to act as a liaison
7		between the Nation and federal agencies and officials; and
8	WHEREAS,	the law firm of Holland & Knight LLP (the "Attorneys") was selected as the Nation's
9		Washington, D.C. lobbyist in 2004 pursuant to Resolution 04-045 and has continued
10		to serve as the Nation's primary lobbying firm in FY 2005, FY 2006, and FY 2007; and
11	WHEREAS,	the Attorneys' FY2007contract ("AttorneyContract") was previously extended for three
12		months through December 31, 2007 but will expire on that date (Resolution No. 07-
13		645); and
14	WHEREAS,	while the Nation's Chairman and the Legislative Appropriations Committee are
15		reviewing proposals from lobbying firms interested in representing the Nation in FY
16		2008, it is in the Nation's best interest to continue employing the Attorneys through
17		March 31, 2008 to allow time to select such a firm; and
18	WHEREAS,	subsection XIII.B. of the Attorney Contract provides that, ``[s] ubject to the availability
19		of appropriated funds, this Contract may be extended by the parties for such
20		additional terms as may be mutually agreeable."; and
21	WHEREAS,	the Nation's Chairman and the Appropriations Committee therefore recommend
22		approval of the attached "Extension No. 2 to the Attorney Contract with the Law Firm
23		of Holland and Knight LLP" for the period commencing on January 1, 2008 and ending
24		on March 31, 2008 in the amount of \$75,000 ("Attorney Contract Extension No. 2").
25	NOW, THE	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
26		(1) approves the Attorney Contract Extension No. 2 with the Attorneys in the amount
27		of \$75,000 for the period commencing on January 1, 2008 and ending on March 31 ,
