

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2008 Additional Apportionment of Gaming Revenues to Districts)**

RESOLUTION NO. 07-764

1 WHEREAS, pursuant to Resolution 07-461, the Tohono O'odham Legislative Council approved the  
2 initial apportionment of gaming revenue based on projected allocation of  
3 \$18,746,856.57; and

4 WHEREAS, the Office of the Treasurer has determined the additional gaming revenue amounts  
5 including interest earned; and

6 WHEREAS, the Office of the Treasurer presented the additional apportionment amounts to the  
7 Legislative Budget and Finance Committee as the following:

21 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
22 approves the FY 2008 Additional Apportionment of gaming revenues and interest  
23 earned to the Districts as listed in the above table; provided that such amounts shall  
24 only be made available for expenditure in accordance with district budgets approved  
25 pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham Nation  
26 and subject to the provision of the Tohono O'odham Code Title 26, Chapter 1, Article  
27 3.

28 BE IT FINALLY RESOLVED that the Office of the Treasurer is authorized to transfer the FY 2008  
29 Additional Apportionment as listed in the above table, subject to the provision of this  
30 Resolution and the Tohono O'odham Code Title 26, Chapter 1, Article 3.


31 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day  
32 of DECEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-  
33 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
34 Section 1 (d) & (2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
35 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
36 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
37 18, 1934 (48 Stat. 984).


